

Membership Terms & Conditions

The following Terms and Conditions are entered into by and between You ("**Client**" or "**You**") and Ideas for Real Estate LLC ("**Company**", "**we**", or "**us**").

Program

The Company agrees to provide you with access to the Program, "The Marketing Suite" ("**Program**"). As a condition of participating in the Program, you agree to be bound by and to abide by all policies and procedures set out in this Agreement, including those incorporated by reference.

Terms of Use, Privacy Policy, & Disclaimer

The Company's Terms of Use, Privacy Policy, and Disclaimer are hereby incorporated by reference into this agreement. Except as modified by this Agreement, each of those agreements and policies shall apply fully to your participation in the Program. In the event of a conflict between any of those policies and this Agreement, this Agreement shall govern.

Nature of The Relationship

Nothing in this Agreement shall be construed to create a partnership, joint venture, employment, or agency relationship. The Company is agreeing only to provide Client with access to the Program, which provides education, content, and information. The information contained in the Program, including any interactions with the instructors, is not intended as, and shall not be understood or construed as, professional advice.

Fees

In consideration of Your access to the Program, you agree to pay the following fees based upon the payment option you chose at the time of purchase.

Monthly Membership. You shall make monthly payments at the current rate as agreed upon when you signed up, with the first payment due immediately. These payments will continue automatically each month on the same date of the month that you originally signed up. For example, if you purchased on April 9th, your next payment would be May 9th and so forth until you cancel your subscription to the Program according to the Program's Cancellation Policy set forth below. Payments are due regardless of the timing of the release of content within the Program.



In the event that any payment is not made or your monthly payment fails to process, the Company shall immediately suspend your access to the Program.

From time to time, the Program will go on sale. However, your monthly payment is what you purchased the Program for. These terms apply to all future sale prices.

If you cancel, your membership is cancelled due to failed payment, or any other reasons that you are no longer a member and you rejoin, you'll be subject to the current pricing terms.

Payment Plan Authorization

You hereby authorize the Company to charge your credit card or debit card automatically according to the terms set forth in the Fees section above.

Cancellation Policy

The Program is offered on an ongoing basis with a monthly or yearly subscription. You may cancel subscriptions at any time by logging into your dashboard and accessing your account.

Your access to the membership shall terminate immediately upon cancellation, and you will no longer have access to The Marketing Suite and the program. You shall not be charged after a cancellation.

No Refunds

All sales are final, and the Company does not offer any money-back guarantees. You recognize and agree that you shall not be entitled to a refund for any purchase under any circumstances.

The Program

As part of the Program, the Company shall provide the following to Client.

Access To Program Area – The Company shall maintain a Program Area that may include lessons, forms, worksheets, checklists, resources, downloads, videos, social media content, email newsletters, and other information. You shall have access to this Program Area as long as you are a member.

Monthly Content – As a member of the Program, you will receive regular content from the Company. Specifically, each month, members will receive a monthly training and/or live coaching session, email marketing newsletter, and social media posts and templates.

Q&A Sessions – As a member of the Program, you will have access to question and answer sessions (or live coaching session). From time to time, an individual session may be canceled



based upon the availability of the instructors. The Company shall provide you with details about how to participate in these question and answer sessions.

Bonuses – From time to time, the Company will offer bonuses to individuals who sign up for the Program. You shall be entitled to any bonuses offered to you at the time of your registration.

Ownership Of All Intellectual Property

All content included as part of the Program, such as text, graphics, logos, images, as well as the compilation thereof, and any software used in the Program, is the property of the Company or its suppliers and protected by copyright and other laws that protect intellectual property and proprietary rights.

Termination And Access Restriction

Waiver

No waiver by any Party of any of the provisions of this Agreement shall be effective unless explicitly set forth in writing and signed by the Party so waiving. Except as otherwise set forth in this Agreement, no failure to exercise, or delay in exercising, any right, remedy, power, or privilege arising from this Agreement shall operate or be construed as a waiver thereof, nor shall any single or partial exercise of any right, remedy, power, or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power, or privilege.

Force Majeure

The Company shall not be liable or responsible to You, nor be deemed to have defaulted or breached this Agreement, for any failure or delay in fulfilling or performing any term of this Agreement when and to the extent such failure or delay is caused by or results from acts or circumstances beyond the reasonable control of the Company including, without limitation, acts of God, flood, fire, earthquake, explosion, governmental actions, war, invasion, or hostilities (whether war is declared or not), terrorist threats or acts, riot, or other civil unrest, national emergency, revolution, insurrection, epidemic, lock-outs, strikes or other labor disputes (whether or not relating to either party's workforce), or restraints or delays affecting carriers or inability or delay in obtaining supplies of adequate or suitable materials, materials or telecommunication breakdown or power outage.



Effective Date

This Agreement shall commence and be enforceable with respect to each Program participant upon the date that the participant initially registers for the Program.
